## Terms and Conditions

- The booking should be made at least 60 days prior to the provisional date of departure. Kathmandu Holiday Tours & Travels Pvt. Ltd. will confirm your booking within 15 days of your application.
- A medical certificate to travel in high altitude and travel and medical insurance should be provided on arrival at Kathmandu.
- The itinerary can change without prior notice due to unavoidable circumstances beyond our control such as political unrest, natural calamities, changes made to the itinerary by Chinese authorities etc. We will inform you about any such changes as soon as possible. In this case company will not be responsible for the client's losses regarding any travel booking made by the client himself/herself.
- A 25% deposit of the total tour cost (of which INR 25000/USD 500) is non-refundable) should be made upon confirmation. The remainder should be paid at least 45 days before the commencement of the tour.
- Any amount paid (with the exception of the non-refundable deposit) will be refunded if the booking is cancelled at least 2 months before the commencement of the tour.

- If the booking is cancelled at least 30 days before of the commencement of the tour, 50% of the amount paid will be refunded. No cancellation will be accepted (and no refunds will be made) after this period.
- A full refund or cash adjustment will be made if Kathmandu Holiday Tours and Travels cancels a trip for internal reasons or other unavoidable circumstances.
- Any unexpected expenses incurred such as rescue/evacuation costs, additional costs due to natural disasters or bad weather, political unrest etc. will be paid for the guest themselves.
- If the necessary permit has already been paid for obtained, then the expenses incurred for the obtaining such as permits and organize support logistics will not be refunded. In this case, the above refund policy will not apply.
- If incase the given route closed due to under unavoidable circumstance such as Chinese authority/natural disaster or any other reason, we will go through other alternate routes. In such conditions clients have to pay cost differences.

## Assumption of Risks, Release and Guarantee

I understand and I am aware that during the tour in which I intend to participate under the arrangement of Kathmandu Holiday Tours and Travels, and its agents and associated employees, certain risks and dangers may arise, including but not limited to the hazards of travelling in remote and mountainous terrain, accident or illness in remote places without the availability of medical facilities or means of rapid evacuation. I further understand and accept that due to the nature of travel in Mt. Kailash and also due to certain terms and conditions imposed upon Kathmandu Holiday Tours and Travel, by the Chinese travel authorities, I will not be eligible for any refund of the cost (including the

non-refundable deposit) if the tour is cancelled once it has actually started. I, however, will receive a full refund if Kathmandu Holiday Tours and Travels cancels a trip for internal reasons such as failure to obtain a Chinese visa or attain the minimum group size. I accept and understand all risks associated with the journey and further agree to abide by the terms and conditions set by Kathmandu Holiday Tours and Travels. In the event of illness, accident, weather, political and other factors beyond their control, I will not hold Kathmandu Holiday Tours and Travels, its agents and associated employees responsible or liable for damages. I understand and travel at my own risk.
